Introduction

This Association welcomes you as a member to the Smile-A-Mile Fun Bus and Toy Library Incorporated. You have access to an extensive range of toys and equipment which provide enjoyment, fun, developmental challenges and learning opportunities for young children.

Membership Entitlements

Membership entitles you to borrow up to **six items (two large and four small items)** at any one time during Toy Library operating hours. The loan period is one month.

Please Note: Three puzzles equals one item.

Membership Responsibilities

Financial members are **fully responsible** for the loss or damage of loaned toys in their care, for the replacement cost if toys or missing pieces are not returned and for the children that play with the Smile-A-Mile Toy Library toys and equipment.

Toys need to be maintained so that they are safe and desirable. If a toy is incomplete when you arrive home please phone, text or email Smile-A-Mile Toy Library with the toy identification number and a detailed description.

If pieces are missing when the toy is returned to Smile-A-Mile Toy Library, you are liable for the replacement of the pieces. Some select toys with small pieces have a \$5.50 (Inc. GST) per piece replacement fee.

If a toy is broken through inappropriate use or neglect, the borrower will be charged the cost price based on a depreciated value.

All toys should be cleaned before they are returned. Please use warm soapy water or a non-toxic cleaning solution. The best steriliser is the sun. An **Uncleaned Toy Fee of \$11.00 (Inc. GST)** per piece will apply for any items that are returned unclean.

Annual Gold Membership Fees are \$88.00 (Inc. GST)

Membership Fees are deposited directly into the Association's Fund Raising Account for the primary use of toy and equipment purchases and toy and equipment repairs and maintenance.

Under Toy Library Terms and Conditions a **Late Return Fee** of \$5.50 (Inc. GST) per week will be charged if toys are not returned within 14 days.

Children

All children who attend Smile-A-Mile Toy Library must be accompanied by an adult and are the sole responsibility of their parents or carers and are not to be left unattended and must be supervised by their parents at all times.

Staff of Smile- A-Mile Fun Bus & Toy Library Incorporated **are not responsible** for the care of children who attend Smile-A-Mile Toy Library. While all due care is taken, Smile-A-Mile Fun Bus & Toy Library Incorporated will **not take responsibility** for children who are injured while at Smile-A-Mile Toy Library.

Smile-A-Mile Toy Library includes the main office building, the carport, the storage shed, the Toy Library demountable and the fenced grounds.

Voluntary Assistance

Smile-A-Mile Fun Bus & Toy Library Incorporated is managed by its own financial members. If you can assist the Association in any way please contact the Management Committee or the Coordinator.
